- E. RIGHT OVARIAN LIGAMENT: FIBROUS ADHESION WITH HEMOSIDERIN-LADEN MACROPHAGES AND FEW STROMAL-TYPE CELLS, PRESUMPTIVE ENDOMETRIOSIS.
- F. RIGHT PERIURETERAL: SCAR TISSUE WITH FOCAL ENDOMETRIOSIS.
- G. RIGHT UTEROSACRAL LIGAMENT: SCAR TISSUE WITH FOCAL ENDOMETRIOSIS.
- H. RIGHT OVARIAN FOSSA: SCAR TISSUE WITH HEMOSIDERIN-LADEN MACROPHAGES AND FEW STROMAL-TYPE CELLS, PRESUMPTIVE ENDOMETRIOSIS.
- I. RIGHT OVARIAN CAPSULE: OVARIAN CORTEX WITH WALL OF ENDOMETRIOTIC CYST, CORPUS LUTEAL CYST, AND FIBROUS ADHESIONS.
- J. FIBROID: SUBSEROUSAL LEIOMYOMA.
- K. LEFT OVARIAN CAPSULE: FIBROUS TISSUE WITH HEMOSIDERIN-LADEN MACROPHAGES.
- L. LEFT OVARIAN ENDOMETRIOMA: OVARIAN CORTEX WITH WALL OF ENDOMETRIOTIC CYST, CYSTIC FOLLICLES, AND ADHESIONS.
- M. LEFT PERIURETERAL: FIBROUS ADHESIONS WITH ENDOMETRIOSIS. OVARIAN CORTEX WITH PORTION OF ENDOMETRIOTIC CYST.
- N. PERIRECTAL: SCAR TISSUE WITH FOCAL ENDOMETRIOSIS.
- O. LEFT OVARIAN FOSSA ADHESION: FIBROUS ADHESION WITH ENDOMETRIOSIS.
- P. LEFT UTEROSACRAL LIGAMENT: SCAR TISSUE WITH ENDOMETRIOSIS.

- C. In formalin labeled "left tube adhesion" is a 0.5 x 0.4 cm pink-tan tissue fragment. Totally submitted 1 block.
- D. In formalin labeled "bladder flap adhesion" are 2, 1.5-2.0 cm gray-pink tissue fragments. Totally submitted, 1 block.
- E. In formalin labeled "right ovarian ligament" are 2, 0.4-0.5 cm pink-red tissue fragments. Totally submitted, 1 block.
